MEMBERSHIP CATEGORIES AT OSOYOOS GOLF CLUB

2017 REGULAR MEMBER

Applies to one individual only (male or female) 19 years and older wanting to maximize use of the facilities on an annual basis. No restrictions on hours or number of rounds played per season.

Membership includes:

- Unlimited play on two 18-hole championship courses
- 6 day advance booking privileges (accepted after 5 pm)
- Zone 2 Membership - includes events, handicap services, and preferred rates
BC Men's and Ladies Association Dues
- Unlimited use of driving range and grass short game practice facility
- South Okanagan Golf Trail benefits - \$49 for golf, cart and taxes after 1 pm
at Fairview Mountain and Nk'Mip Canyon Desert
- 15% off all golf apparel, shoes and accessories
- Discount on golf equipment and FREE custom club fitting
- Discounts on OGC Tournaments and member events
- GOLF CANADA handicap, record keeping and certification
- Discount on green fees for guests (up to 11 per day-max 3 tee times)
- Discount on daily cart rental, includes guests
- Annual cart rental, club storage and locker rental available
- Private trackage, with or without storage, available
- Outside Service Program
- Full voting rights and eligible to hold any Society office.

One time initiation fee for member status is non-refundable and non-transferable. This is a non-equity membership.

2017 RETAINER MEMBER

Designed for an individual 19+ years wanting to retain Member status but not able to maximize use of the facilities on an annual basis. No restrictions on hours/rounds played per season. Membership includes:

- Preferred green fee rate, as determined annually by the Board of Directors
- Additional Regular Member benefits included (excluding unlimited play)

One time initiation fee for member status is non-refundable and non-transferable. This is a non-equity membership.

2017 RETAINER PLAY PACKAGE

Designed for an individual, 19 years and older, wanting to retain Member status with limited playing privileges on an annual basis. Membership includes:

- Retainer Membership Fee
- Maximum of 25 starts – no restrictions on the course or time of play
- Additional Regular Member benefits included (excluding unlimited play)
- Preferred green fee rate on any additional rounds

One time initiation fee for member status is non-refundable and non-transferable. This is a non-equity membership.

2017 INTERMEDIATE MEMBER

Designed for an individual between 19 and 24 years old wanting to maximize use of the facilities on annual basis. No restrictions on hours or number of rounds played per season. Membership includes:

- Unlimited play on two 18-hole championship courses
- 6 day advance booking privileges on either course
- Additional Regular Member benefits included
- No voting rights or eligibility to hold Society office

The requirement to pay the one time initiation fee for member status would be postponed until the year in which the individual's 25th birthday occurs. At the age of 25 the individual would be eligible to become a Regular Member with the total of all annual fees paid as a JUNIOR member applied to the initiation fee. This is non-refundable and non-transferable. This is a non-equity membership.

2017 UNIVERSITY MEMBER

Designed for an individual enrolled in full time studies at any College, University or Technical School who wants to maximize use of the facilities on an annual basis. This member status assumes the individual will be restricted in their ability to play an ordinary amount of golf throughout the season. Membership includes:

- Unlimited play on two 18-hole championship courses
- Additional Regular Member benefits included
- No voting rights or eligibility to hold Society office

The requirement to pay the one time initiation fee for member status would be postponed until the year in which the individual's 25th birthday occurs. At the age of 25 the individual would be eligible to become a Regular Member with the total of all annual fees paid as a JUNIOR member applied to the initiation fee. This is non-refundable and non-transferable. This is a non-equity membership.

2017 JUNIOR MEMBER

Designed for an individual between 13 and 18 years old who is in FULL TIME attendance at a local elementary or secondary school, or be under the care of parents or legal guardians who are Regular Members of the Club. Membership includes:

- Unlimited play on two 18-hole championship courses
- Tee times may be governed at times by the Pro Shop
- Must hold a valid driver's license to operate power cart
- Unlimited use of driving range and grass short game practice facility
- No voting rights or eligibility to hold Society office
- GOLF CANADA handicap, record keeping and certification

2017 JUNIOR UNDER SUPERVISION

Designed for an individual between 6 and 12 years old whose parents or guardians make application in the prescribed form. Membership includes:

- Restricted to play under the supervision of an adult 19 years and older
- Release form of liability to be signed by parent/guardian prior to approval of application
- No voting rights or eligibility to hold Society office
- Tee times at this category will be governed by the Pro Shop

2017 TEMPORARY RESIDENT / PGA MEMBER

Designed for individuals 19 years and older with an occupation that requires regular or periodic transfer. Also accommodates PGA Professionals (retired or unemployed) residing in the region who desires to play more than the once a month courtesy of his PGA privilege. Membership criteria includes:

- Limited to *40 rounds per year* – rounds in excess are charged at a guest rate
- May only be held for a maximum of 5 consecutive years
- 6 day advance booking privilege – all other benefits as per Regular Member
- Must produce a company letter outlining nature of employment and duration in Osoyoos region
- No Initiation fee, voting rights or eligibility to hold Society office
- May not become Director or Employee of the Club
- Not eligible for private cart usage, trackage or storage

TR Membership is assigned to an individual and is non-transferable or eligible to be used by any other person.

PGA Member must produce, annually, a current PGA Membership card, validated as a Member in good standing of their association. The PGA must be a recognized PGA. Approval at the sole discretion of the Head Golf Professional and Board of Directors.

2017 PLAYING PRIVILEGE PACKAGE - \$2,300 + tax

Designed for those wanting to maximize use of the facilities for annual golf season without becoming a member of the Osoyoos Golf Club. This is a NON-MEMBER package which includes:

- Unlimited play on two 18-hole championship courses
- Unlimited use of driving range and grass short game practice facility
- Discounted cart rental
- \$200 credit per consecutive years paid, towards purchase of Initiation Fee
- No voting rights or other member benefits as outlined above

2017 MEMBER REFERRAL PROGRAM

To encourage and reward members who take an ambassador role in promoting the purchase of memberships at the Osoyoos Golf Club. Qualification terms:

- Member MUST pre-register the name of the prospective purchaser prior to any club employee discussions with the prospective purchaser
- General Manager will validate that this referral qualifies prior to the purchase or sale of membership
- Members in good standing who do successfully refer a purchaser under the terms above will receive a credit to their account to be used for Pro Shop purchases. The referral program credit is not designed for payment towards member dues.
